Welcome	Comments
1. Meeting opened at 7.05pm.	Introduction by the current interim chair with a welcome and the request for a minute's applause for our past chair Chris Snell.
2. Chairs report	A brief report was provided as to how things had progressed since October 2021
3.Treasurer's Report	The current interim treasurer provided confirmation that following discussions in October 2021 the old bank a/c with HSBC would be closed and a new A/c be sourced and opened, which is now with Santander. The current A/c stands at approximately £2k. This was helped by the prompt payment by all members of their plot fees, still to pay the landlord for this year's rent and the contribution donated from the collection made at the funeral of Chris Snell. The accounts + minutes from meetings are now on the web site.
4.Update from John Vickers	As a legacy to Chris, it had been proposed that all plots where appropriate should have access to a shed along with some form of water collection, a request was made to members who might hear of or be aware of any shed that might be surplus to make any committee member aware. It had been suggested that an additional entrance be made into the dividing hedge to allow access to each side of the allotment, exactly where this would be is still to be established, and a show of hands was asked for to gauge the members approval. Whilst all members were not present the show of hands concluded 7 for with 4 against, further discussions would take place with other members and a vote taken to be passed by a simple majority. Machinery: reminder to members that they are required to ensure any machinery used is cleaned and filled with petrol. The committee would provide 2 stroke petrol for the strimmer and hedge cutter. The issue over the infestation of rabbits within the site was being resolved.
